We began operating under the Solenis name in 2014 following the acquisition of Ashland Water Technologies by funds managed by the private investment firm Clayton, Dubilier & Rice (CD&R).

In January 2019, we joined forces with BASF's paper and water chemicals business, enabling us to provide expanded chemical offerings and cost-effective solutions to our customers around the world. Today, BASF owns 49 percent of the combined company and 51 percent is collectively owned by Solenis management and funds managed by CD&R.
